

# CODE OF CONDUCT

By visiting the Shopping Centre, you agree to comply with these Rules. If you do not agree with these Rules, you must leave the Shopping Centre immediately. These Rules were last updated on January 31, 2024, any modifications or updates will be binding on you as soon as posted.



### NO SMOKING OR VAPING

The Shopping Centre is smoke-free. Smoking or vaping of any substance, including tobacco and marijuana/cannabis, is not permitted indoors or within 10 meters of any entrance or covered area.



### NO ALCOHOL

Consuming alcohol is not permitted, except in specifically designated areas.



### ACCESSIBILITY

### NO SOLICITING

To ensure the safety, soliciting and distributing literature or pamphlets of any kind and for any purpose, including engaging in protests, strikes, petitions, and surveys is strictly prohibited, except with our prior written approval.



### APPROPRIATE ATTIRE

Appropriate attire must be worn while inside the Shopping Centre. Attire that will be considered objectionable includes anything that is intended to conceal your identity, is lewd, unsafe, promotes hatred, or incites violence or conflict.



### SERVICE ANIMALS

Service animals are permitted but pets, except otherwise stated, are not allowed.



### BE CONSIDERATE

Cycling, rollerblading, skateboarding, hover boarding, running, and speedwalking, unless otherwise stated, are not allowed. You must not interfere with any other individuals' enjoyment of the Shopping Centre, including littering, profane language, mischief, vandalism, playing music, making loud noises, wearing strong scents, or using the elevators, stairs, or furniture in an unsafe manner. Any act that violates Municipal, Provincial or Federal laws or regulations is prohibited.



### FOOD COURT

During rush periods, we may ask you to leave the food court or other seating area after 30 minutes.



### NO PHOTOS

Personal entertainment and electronic devices may only be operated within accepted locations and without any loud or undue sound. Unless you have our prior written consent, you may not take any videos or photos.



### NO LOITERING

Loitering is prohibited. Keep all common hallways, passageways, and corridors clear and shop in groups of four people or less.



### PRIVACY POLICY

We may take photos and videos of the Shopping Centre, which may include you, for commercial, advertising, and marketing purposes. You agree to our use of your image and other personal information, without any remuneration, for all such purposes. Video recording and other types of tracking, monitoring, and identification technologies have been implemented throughout the Shopping Centre for security, marketing, and property management purposes.
