

## Win a \$500 Back-To-School shopping spree Contest

1. **CONTEST PERIOD:** Starting on Monday August 25 at 10 AM and ending on Sunday September 7, 2025 at 5pm at Eastern Daylight Time (the "Contest Period"). NO PURCHASE NECESSARY OPTION AVAILABLE.
2. **ELIGIBILITY:** To enter and be eligible to participate in the promotion, a person must be a resident of Ontario and be the age of majority in Peterborough, Ontario. The Sponsor of this Contest is Lansdowne Place (the "Sponsor"). The following persons are NOT eligible to participate in this Contest: a) a director, officer, manager, employee, or agent of the Sponsor, Primaris Management Inc., or any of the tenants or other occupants of Lansdowne Place (the "Shopping Centre") or their employees, affiliated companies, franchisees, service agencies or independent contractors of the Sponsor; b) individuals engaged in the development, production or distribution of materials for the Contest and c) any person domiciled with any of the above.
3. **HOW TO PARTICIPATE:** Starting Monday August 25 at 10 AM, make a purchase at any Lansdowne Place retailer, food court vendor, service or restaurant valued at \$100 or more, and redeem your receipt(s) at Guest Services for a ballot. One ballot for every \$100 spent. Receipts must be dated between August 25, 2025 and September 7, 2025. Receipts can be combined to reach \$100 and eligibility.
4. **NO PURCHASE NECESSARY:** Customers can write a 500-word original essay on why they would like to win \$500 back to school shopping spree (1 essay = 1 ballot), and submit to Guest Services during the contest period along with the code word. Entries mechanically reproduced or made in any other fashion other than the original entry form, or a hand-drawn facsimile are void. The Sponsor is not responsible for lost, late, misdirected, postage due, damaged, illegible, or incomplete entries or any printing errors in these Rules. **Purchase does not enhance a person's chance of winning.**
5. **PRIZE DESCRIPTION:** One prize pack available to win. Prize pack consists of: One (1) Lansdowne Place Gift Card valued at \$500,
6. **HOW TO CLAIM YOUR PRIZE:** On or about **Monday September 8<sup>th</sup>, 2025**, at approximately **12 PM Eastern Daylight Time**, an independent Primaris representative "judge" will randomly select one winning ballot from all eligible entries received by **5 PM on September 7<sup>th</sup>, 2025**. Judges will attempt to contact the potential winners, between 12 PM and 5 PM, Eastern Daylight Time, immediately following the draw. If the Judges are not able to make contact and speak directly with the selected entrant within the allotted time, then at the sole and absolute discretion of the Judges, that entrant may be disqualified, his/her entitlement to receive a prize may be forfeited, and an alternate eligible entrant may be randomly selected from remaining eligible entries. **Potential winner will be required to correctly answer, without assistance of any kind, a skill-testing-time limited mathematical question.** Prizes are not transferable, and must be accepted as awarded, with no substitution of any kind, except by the Sponsor, who reserves the right to substitute a prize of equal or greater value.

Entrants who have not complied with these Contest Rules and Regulations are subject to disqualification.**
8. If a potential winner is found to be ineligible or, declines to accept a prize, the prize will be forfeited. The potential winner may be required to furnish proof of identification that may include a driver's license. The Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Contest in whole or in part, in the event of fraud, technical or other difficulties or if the integrity of the Contest is compromised, without liability to the entrant. The Sponsor reserves the right to disqualify any entrant or winner, as determined by the Sponsor in its sole discretion. This Contest is subject to these Contest Rules and Regulations and all applicable federal, provincial, local, and other laws. Void where prohibited or restricted by law. These Contest Rules and Regulations are governed by the laws having application in the province where the Shopping Centre is located. Any action or proceeding arising out of, or in connection with, this Contest or these Contest Rules and Regulations must be brought in the Court of the Province where the Shopping Centre is located.
