OFFICIAL RULES

1. CONTEST DESCRIPTION AND HOW TO ENTER

Contest Period:

The contest will run from **Saturday, February 7, 2026**, until **Saturday, February 15, 2026**, at **5:00 PM EST**.

How to Enter:

To participate, contestants must visit **Eglinton Square**. Complete contest ballot and deposit the ballot in the ballot box at Eglinton Square before February, 15, 2026.

Prizes:

Three (3) winners will each receive a **\$100 gift card** from a store of their choice located at **Eglinton Square**. The selected store must offer gift cards for redemption.

2. SELECTION OF WINNERS AND PRIZE CLAIMS

Winners will be contacted via email or telephone by no later than Wednesday, February 18, 2026. Prizes must be accepted as rewarded. Winners must pick up the prize at Eglinton Square. Photo ID will be required.

3. ELIGIBILITY

5. CONSENT TO COLLECTION, USE AND DISCLOSURE OF PERSONAL INFORMATION
